Minutes the meeting held in Knayton Village Hall at 8.15pm on May 21st 2018.

Present: Cllr. Scott, Cllr Gibbon and Cllr. Cowton and five members of the public and County Councillor G. Dadd and District Councillor R. Baker for part of the meeting.

18.63 Members of the Public. Questions had been asked during the Annual Parish meeting.

18.64 Apologies for absence were received and accepted from Cllr. Smith.

18.65 There were no declarations of interest in items on the agenda.

18.66 The minutes from April 16th 2018 were approved and signed.

18.67 Cllr. R. Baker reported that there was no update on the Planning Enforcement issue.

18.68 Cllr. G. Dadd commented about the recent press article concerning County Councillor allowances. An independent Panel recommended the increase, but Cllr Dadd stressed that many County Councillors, himself included don't take the increases. Salaries of NYCC Senior Officers are 15% less than colleagues in the rest of the Country and they have had no increase.

18.69 Clerk's Report and Correspondence. See below.

18.70 In light of few Councillors being present it was decided to defer a decision regarding repairs to Back Lane. However, it was noted that NYCC had quoted £3000 for the job which was felt to be excessive. It was noted that since sending that quote, the PROW Officer had not replied to telephone calls or emails, so it was unknown how much the NYCC would donate.

18.71 **Financial Matters.** Revised Financial Regulations were adopted with an increase in the amount of spending that can be authorised out of a meeting to £200.00.

It was agreed to submit the Certificate of Exemption from External Audit.

The 2017/2018 Accounts were approved prior to being sent for Internal Audit.

A report from the Employment Committee recommended that the Clerk's hours be increased from 2 hours a week to 3 hours a week in light of the increased work load.
